Board of Directors of the HDC's Subsidiary Companies Receive Instruments of Appointment

The Minister of Housing and Urban Development, The Honourable Camille Robinson-Regis, and Minister in the Ministry of Housing and Urban Development, the Honourable Adrian Leonce, presented instruments of appointment to the Board of Directors of the Trinidad & Tobago Housing Development Corporation's (HDC) subsidiary companies on Thursday 22 December, 2022. The presentation took place at the Ministry's Conference Room, South Quay, Port of Spain.

The three (3) subsidiary companies and the Directors who were presented their instruments are:

Upon receiving their instruments of appointment, the Board of Directors for each subsidiary will begin a one-year tenure. The HDC will become the holding company of the three subsidiaries which are tasked with: 1) construction and fulfilling the HDC's property development mandate, 2) managing the HDC's assets, and 3) maintenance of the HDC's facilities and fulfilling the HDC's property management mandate.

In her remarks during the presentation, Minister Robinson-Regis reaffirmed the commitment of the government and the HDC to the people of Trinidad and Tobago. "Today, the Government and the HDC declare that we are not averse to change that will redound to the benefit of the citizens of this blessed Republic. We are prepared to do what is necessary, what is right, and what is demanded of us by the citizens who are all deserving of a level of service from the HDC and its subsidiary companies that is unparalleled in the history of this country".

The Board of Directors were commended by Minister Robinson-Regis for accepting the call to serve their country, and being appointed into their critical roles.

Mr. Noel Garcia, Chairman of the Board of Directors of the HDC, said he was honoured to be part of this historic development in the life of the HDC because the new subsidiary companies signal a change in the way the HDC will conduct business moving ahead, as it seeks to create an organization that is as lean as it is productive, and focused.
